- 1. All AEs (who are in Maintenance/ OG/ Stores & Transport/ Construction Projects) except attached officers and posted in shifts in Power Stations/ Dams/ Barrages.
- 2. Wired Internet Connections be provided to Control Rooms of all Dams/Barrages/Power Stations (LHPs, MHPs and SHPs). At places where wired broadband connection cannot be provided, the same can be alternated by a wireless dongle/ radio connection.

All JEs or equivalent personnel who are in Maintenance/ OG/ Stores & Transport/ Construction Projects shall access the ERP application through the internet dongles of their AEs.

In this connection, it is again requested to ensure Internet connectivity at sites for accessing ERP application.

In case of any difficulty in this regard, may kindly immediately informed to this office, so that further necessary action can be taken.

The ERP solution, designed and developed by M/s Accenture has been tested by the core team and the End User training of the tested modules is about to be completed at "Ujjwal", Dehradun. The ERP system is under review at GM/Director levels and will be ready for Go Live stage in the coming time.

For accessing the ERP application over the internet, communication facilities are required to be augmented. In this context kindly refer the Office Memo no. 5297/UJVNL/MD/C-18 regarding provisioning of internet to officers/officials. The following personnel may be provided the facility under the memo.

- 1. All AE's (who are in Maintenance/ OG/ Stores & Transport/ Construction Projects) except attached officers and those posted in shifts in Power Stations/ Dams/ Barrages.
- Wired Internet Connections be provided to Control Rooms of all Dams/Barrages/Power Stations (LHPs, MHPs and SHPs). At places where wired broadband connection cannot be provided, the same can be alternated by a wireless dongle/Radio connection.

All JEs or equivalent personnel who are in Maintenance/ OG/ Stores & Transport/ Construction Projects may access the ERP application through the internet dongles of their AE's.

The personnel who are already having internet dongles, need not be provided any extra internet dongle for using ERP system.

### OFFICE MEMORANDUM

After the implementation of e-tendering for the tender value of Rs. 5.00 Lacs & above for goods, works and consultancy etc., it is felt necessary to spengthen the backhand of IT services by providing latest generation wireless broadband services to the officers of UTVN Limited at and above the level of Executive Engineers and equivalent for greater sense of empowerment and better delivery of results for execution of projects.

- 1. Administrative Approval to procure wireless broadband Services (2G/3G/Latest generation) shall be given to concerned General Managers of different offices/ sites/valleys. General Managers should strictly ensure the full justified genuine requirement against the work reasonableness of work
- 2. While processing the proposal of approval for wireless broadband services against fresh requirement, the available existing broadband facilities should be examined at the level of GMs.
- Offices/sites/valleys who have to avail wireless broadband facility should ascertain the best facility of wireless broadband in their areas, with justified reasonableness.
- Tariff Plan of various service providers may be studied and possibility may be explored to have wireless broadband device free of cost unconditionally.
- The bandwidth specification shall be 10 GB unlimited with upto 7.2/9.8 Mbps speed. It should be ensured that devices should be compatible for further technology advancement.
- Purchase Committee shall exercise financial approval as per delegation given in DoP.
- Purchase order shall be released by the office of Concerned DGM/EE.

The expenses of broadband services shall be borne by the individual units/offices under the head A&G expenses, in the similar way to that of Landline phones/mobiles.

- For providing wireless broadband facility to AEs, decision will be taken by GMs by ensuring genuin eness of requirement & broadband facility availability on office land the phones being used in clusters and then administrative approval be sough from concerned Director.
- 10. Units headquartered at Dehradun:-

a) having the posting of GMs may also have the option to raise their requisitions to DGM (IT). but they have to borne and pay for the services under A&G expenses of their office.

for not having the posting of GMs shall raise their requisitions to DGM (IT) through ED/ Director's, but they have to bome and pay for the services under A&G expenses of their office.
